On behalf of the Governor of Tripura, separate sealed tenders are hereby invited by the undersigned from well reputed, bonafide, resourceful, registered manufacturing company/industry of sports goods item wise specified in the list which will be available with the tender terms & condition on the Departmental website and from the office of the undersigned:

The last date of receiving of tender is up to 3:00 p.m. on 22.01.2016 during official hours excluding holidays and tender box will be opened at 4:00 p.m. on .22.01.2016 if possible. The tenderer will drop the tender paper in sealed envelope, along with essential and mandatory documents by observing all terms and condition and formalities as prescribed, directly in the tender box or by registered post addressing to **the Director, Youth Affairs & Sports, Govt. of Tripura, Dasaratha Dev State Sports Complex, Badharghat, Pin – 799003, Agartala.** No tender paper shall be received & allowed to drop after 3:00 p.m. on 22nd January 2016. Tenderer may remain present in time of opening the tender box. Requirement of sports goods for getting supply may increase or decrease item wise separately. The rate must be quoted in both figure and words inclusive of all Taxes / VAT and transportation charges etc. Best quality items at lowest rate shall be selected for procurement.

TERMS AND CONDITIONS

1. Sealed cover tender should be addressed to the Director, Youth Affairs & Sports, Govt. of Tripura, Agartala, Tripura West.
2. Details Item wise sports goods quantity; specification, and terms & conditions will available in the office of the undersigned between 11:00 a.m. to 2:00 p.m. on all working days w.e.f. 1st January to 22nd January 2016 by 2 p.m on production of documentary proof as registered manufacturing company/industry of sports goods of product, ITC, PTC, VAT clearance for dropping of tender along with up to-date valid license/registration certificate of manufacturing company/industry for supply best quality sports goods.
3. The tenderers will have to submit the earnest money as indicated in the Notice Inviting Tender with their tender. The earnest money should be deposited in the State Bank of India or any scheduled Bank of India guaranteed by the Reserve Bank of India in the shape of "**Deposit at Call**" in favour of the DDO of the Directorate of Youth Affairs & Sports, Agartala. Earnest money in any other form will not be accepted. Tender without earnest money, unless exempted, shall be summarily rejected. Intending tenders may submit their tenders along with sample as per prescribed specification mentioned in the list of items on or before the stipulated date and time, in the Office of the undersigned.
4. Rate should be typed any quoted inclusive of all components such as supply, all taxes and duties, royalties, loading to truck, carriage to destination (i.e. Directorate of Youth Affairs & Sports, Agartala), unloading and stocking properly as per direction of the Store Keeper etc. complete in all respect. Rate should also be separate against each of the item clearly both in figures and words. Over writing of figure will not be entertained. The bidder / tenderer will offer 3 (three) types of rate as per brand, specification/size, quality item wise along with sample of each item for rate wise of sports goods.
5. Sample of quality as per specification of the sports goods should be offered at the same time when tender is dropped. The sample shall be retained in the office of the undersigned till the date of opening of the tender. The sample should be contained in the sack with ceiling which will be opened at the time of opening of tender in presence of the members of the purchase committee of the Department. The samples of the successful tenderers will be retained in the office until completion of supply for the purpose of comparison with the sports goods as and when supplied.
6. Authorized dealers of reputed manufacturers may drop tenders for supply of the sports goods. Attested copy of certificates relating to

manufacturer / Authorized dealership / reputed supplier of the Manufacturer certificate are to be submitted along with tender.

Payment will be made on presentation of bills in triplicate after completion of supply within stipulated date.

7. Department will be at liberty to get the samples tested by the expert of the Department and supply of the sports goods shall be considered if recommended by the expert on test. Lowest rate against the best quality product of sports goods of each item wise shall be selected separately by considering valid papers & documents of the bidders/tenderers as mentioned therein. The total volume of purchase amount mentioned in the NIT above may increase or decrease. An expert committee is reconstituted for checking the quality & Selection of each item of sports goods and the committee will determine the quantity and volume of purchase on the basis of best quality & lowest price against each item separately.
8. Time is the essence of supply and no extension of time will be allowed without valid reasons. Phase wise schedule for supply of quantities within stipulated time is to be furnished along with tender, if asked for the Department.
9. Any lot or quantum of materials if found not acceptable, will have to be removed from the Office immediately after intimating the Directorate and replacement shall be made forthwith.
10. The accepting authority reserves the rights to accept or reject all tenders including the lowest one without assigning any reasons thereof.
11. Documentary evidence of transportation by truck or any means from the accepted factory / workshop should be produced at the time of supply. Tenderers are also requested to submit the copy of order placed to manufacturer for supply of the said sports goods.
12. The successful tenderers are to deposit the security money @ Rs.10% of the contact value without any ceiling limit.
The earnest money which is already deposited by the successful tendered will be treated as part of security money.
13. The security money of the successful tenderers will be refunded on finalization of supply on satisfaction.
14. Manufacturer / Tenderers /Suppliers have to submit the clearance certificate on VAT from the Sale Taxes Authority at the time of supply of materials: otherwise action regarding deduction of tax at
