N O T I F I C A T I O N

SUBJECT : "Tripura Sports Stipend Rules-1986-Amendment (Second) thereof"

The Tripura Sports Stipend Rules have been introduced in the year 1986 with Amendment (first) in the year-1991. The Sports Stipend Rules, 1986 needs further change in view of new nomenclature of the Directorate of Youth Affairs & Sports under Rule 2(a) modification of provision of Rules 3(i), 3(iii), 5(i), and 6(i) and inclusion of a new para under rules 7.

2. Now the govt. have approved the said rules as amended by the Council of Ministers in a meeting held on 4th Feb, 1999.

The other rules as per amendment (first) made in the year 1991 would remain unchanged.

3. SHORT TITLE AND COMMENCEMENT :

3(a). These rules may be called "Tripura Sports Stipend Rules-1986-Amendment (Second) thereof.

3(b). They shall come into force with effect from the date of their publication in the Tripura Gazette.

4. AMENDMENT OF RULE 2(a): "Director" means the Director, Youth Affairs & Sports or the Officer declared as Head of Department of the Directorate of Youth Affairs & Sports.

5. AMENDMENT RULE 3(i): Is below the age of 16 years on the 1st day of January of the year in which the Stipend is awarded. In case of non-availability of ST/SC, candidates to fill-up their quota within this age group, relaxation of 3 years may be allowed to ST/SC students for filling up quota if necessary.

6. AMENDMENT RULE 3(iii) : Selection made on the Merit of Sports performance during previous year of School Sports i.e. 1st April to 31st March in all the games and Sports in the following manner :-

- (a). National Level Prize winner/participation.
- (b). State Level 1st position/ 2nd position/ 3rd position in case of individual events.
- (c). District Level 1st position in case of individual event.
- (d). State Level Championship/Runner-up in case of group games.
- (e). District Level Championship in case of group games.

2. AMENDMENT RULE 5(i) : The rate of Stipend per month shall be decided by the Administrative Department from time to time with the prior concurrence of Finance Department.

8. AMENDMENT RULE 6(i) : The application of Stipend shall be made in form prescribed by the Department and shall be submitted to the Director through The H.O. & D.D.O. of respective YAS Office, so as to reach this Directorate not later than 30th June of the year in which it relates, but the govt. may extend time, if necessary.

9. INCLUSION OF NEW PFRA UNDER RULES 7 : The students eligible for Stipend shall be selected by a Board to be constituted by the Director with persons having proficiency in different branches of Sports and games.

While selecting the eligible Sports students for Stipend under the Rules against the yearly target, the Board will prepare a pannel of additional 150 Sports Students according to their performance. In case any Vacancy arises in the event of surrender of State Stipend by any awardee due to his/her receipt of National Stipend, the same will be filled up from amongst the Sports students listed in the said pannel.
